Sealed Bids for constructing Water Reclamation Facility Improvements for THE BOARD OF WATER, LIGHT AND SINKING FUND COMMISSIONERS OF THE CITY OF DALTON, GEORGIA will be received in the Auditorium of the Utilities Building at 1200 V.D. Parrott Jr. Parkway until 2:00 P.M., local time June 8th, 2017 at which time and place they will be publicly opened and read.

The work to be performed shall consist of furnishing all materials, tools and equipment and performing all labor necessary for constructing water reclamation system improvements as set forth in the Bid, as shown on the Drawings and as Specified. The work generally consists of replacing pumps, motors, piping, valves, and electrical equipment in the existing Reservoir Pump Station. Time allotted for this contract is 365 consecutive calendar days.

Bids shall contain prices, in words and figures, for the work bid on. All bids shall be submitted on the bid form included in the Contract documents. All bids must be accompanied by a certified check, or a bid bond of a reputable bonding company authorized to do business in the State of Georgia, in an amount equal to at least ten percent (10%) of the total amount of the bid. The bid bond shall be prepared on the form of the bid bond attached to the Contract Documents or a surety company's standard bid bond, duly executed by the Bidder as principal and having as surety thereon a surety company licensed to do business in the State of Georgia and listed in the latest issue of the United States Treasury Circular 570. Upon the proper execution of the agreement and required bonds, the checks or bid bonds of all bidders will be returned to them.

Pre-qualification of bidders for this project is required as described in Document 00 21 13. Bidders shall submit a pre-qualification documentation package to the office of Wiedeman and Singleton until 5:00 P.M., local time, Friday, May 5th, 2017. All applicants submitting pre-qualification documentation will be notified of their status by Tuesday, May 9th, 2017. **Only bids submitted by properly pre-qualified bidders will be opened.**

A Mandatory Pre-Bid Conference will be held for all Bidders on Friday, May 12th, 2017, at 10:00 a.m. in the Conference Room at the Laboratory Building located at 2131 Riverbend Road, Dalton, Georgia. Only bidders in attendance for the entire meeting will be allowed to bid the project. No one will be allowed to enter the pre-bid conference after 10:00 a.m.

All bidders must be licensed contractors as required by Georgia Law Code 43-14-8.2, State of Georgia. The utility contractor license number shall be written on the face of the bid envelope; otherwise, the bid shall not be opened. If two envelopes are used, this information must also appear on the outer envelope.

A contract performance bond and payment bond, each in an amount equal to one hundred percent (100%) of the agreement amount, will be required of the successful bidder.

In accordance with the Georgia Security and Immigration Compliance Act (SB 529), any contractor or subcontractor wishing to or providing services to Dalton Utilities must participate in the E-Verify program. Contractors and any sub contractors used for the said project will be required to submit the completed affidavit as required in these specifications for the Owner's permanent records.

Except as provided in O.C.G.A. section 36-91-43, no submitted bid may be withdrawn for a period of sixty (60) days after the scheduled closing time for the receipt of bids.
